This is regarding State Bank of India partnership with UIDAI for implementation of the UID Mission.

2. As per the present strategy, enrolment into the UIDAI system is proposed to be carried out by various entities of the Central/State Governments, Public Sector Undertakings and other organisations, which in the normal course of implementation of their programmes, activities and operations interact with residents. These entities are described as "Registrars" in the UIDAI terminology. Banks, therefore, are one of our potential registrars, who may be interested in enrolling its present as also the potential account holders.

3. As the biometric attributes of the residents will be the basis for ensuring uniqueness, it is necessary that resident data (including biometric attributes) is captured through a standard process. I am enclosing herewith the copies of the Reports of the Committee on Demographic Data Standards and Verification Procedure and the Committee on Biometrics Design Standards which provide a detailed specifications of the demographic and biometric data to be collected along with the verification processes.

4. In view of the above requirements, an MoU will have to be signed between the Registrars and UIDAI. This MoU sets out the broad terms of engagement and the responsibilities of the parties to the MoU in the course of implementation of the project. We have signed such MoUs with a number of State Governments.

5. I am enclosing here a draft of the proposed MoU to be signed between State Bank of India and the UIDAI. You may have this MoU examined at your end and provide us with your comments, or the revised draft (wherein the insertions/deletions/edits have been clearly highlighted). We can, thereafter, mutually discuss the draft and finalise it.

Looking forward for an early response from your end.
