Question 1 : Legal standing of Report prepared by the Standing Committee on Finance (42) dated 09.12.2011.

Reply : The 42<sup>nd</sup> Report of the Standing Committee of Finance is under consideration of the Government.

Question 2 : Copy of the Govt. Order whereby the UIDAI has been given statutory authority inspite/despise of above stated report.

Reply : Copy of the Notification dated 28.01.2009 is enclosed (03 pages). → not attached.

Question 3 : Copy of all orders, Notifications & Government Resolutions received by Ministry of Law & Justice for all prior implementation of UIDAI.

Reply : No such documents exists with UIDAI.

Question 4 : Copy and legal interpretation of Article 73 of the Constitution of India.

Reply : Copy of the Article 73 of the constitution of India, as downloaded from the website of Ministry of Law & Justice (MoLJ) is enclosed. Providing legal interpretation of the Article of the constitution is not covered under RTI Act. → not attached

Question 5 : Copy of the response from the Ministry of Law & Justice when UIDAI scheme started and continued to be implemented under Draft NIAI Bill 2010 purely on an Executive Order by avoiding the consideration of the said Bill on the same subject pending before the Parliament and after it's rejection by the Standing Committee on Finance through it's report (42) dated 09.12.2011.

Reply : No such documents exist with UIDAI.


