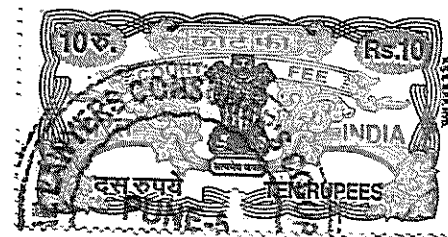

1. Copy of all Guidelines, Notifications, Orders & Government Resolutions received by the Government of Maharashtra for and prior implementation of UIDAI
2. Copy of the Govt. Order that the GAD (IT) Govt. of Maharashtra has received whereby the UIDAI has been given statutory authority
3. Till date the list of partners, enrolment agencies, sub enrolment agencies that the GAD (IT) Government of Maharashtra has appointed to act as State and Non – State Registrars for implementation of the scheme in Maharashtra in Phase I, Phase II, along with list of government verifier nominated at each EA location till date
4. List of partners, enrolment agencies that have been blacklisted and / or withdrawn till date along with reason and date
5. List of kit / s lost / missing from enrolment agencies and copy of FIR / s lodged for that along with copy of public notice informing the public who were effected
6. Public notice informing public the list of enrolment agencies and non-state registrars have been closed, blacklisted, withdrawn and / or services terminated along with date when action was taken
7. List of Non-State Registrars appointed who were / are not operating at locations that were approved by respective district / municipal authorities in Maharashtra

13. List of enrolment agency and amount with reason of any bank guarantee called in till date
14. Copy of the Memorandum of Understanding (MoU) executed by the Government of Maharashtra through you with nominated partners including roles, responsibilities and confidentiality, privacy and protection clause for data collected
15. List of all the schemes under the Government of Maharashtra that have beneficiaries for cash transfer / subsidy under the Government of Maharashtra

Copy of the Standard Operating Procedures & Systems that the Government of Maharashtra through you would implement and the mechanism that would be utilized to collate, integrate, migrate and authenticate any individual's UIDAI card when available to that individual identity and the subsidy he / she would be eligible for
