As you are aware that three Scheme viz. Merit-cum-Means based Scholarship Scheme, Post-matric Scholarship Scheme and Maulana Azad National Fellowships for the students belonging to the notified minority communities have been identified to effect the Direct Cash Transfer in the 43 Districts where UID Aadhar Card have been made on pilot basis.
