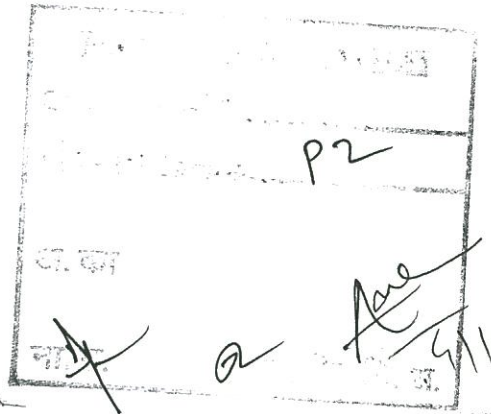

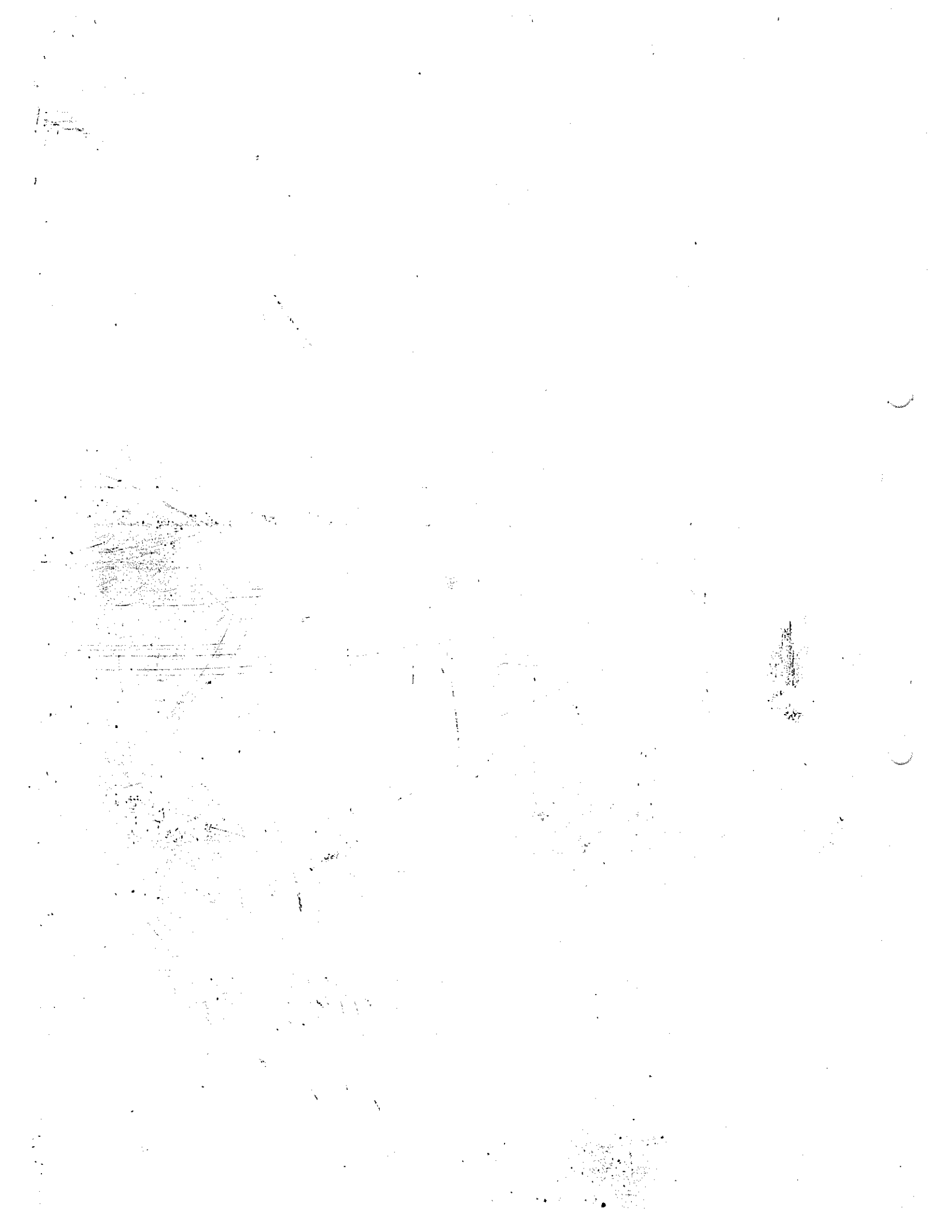

Subject: Seeding of UID with Bank account number for beneficiaries under Financial Inclusion Program

Dear Sir/ Madam

This is with reference to the Apex Committee Meeting for UID held on 13th December 2012, (Ref. No 1) and under Financial Inclusion program for direct cash transfer to the beneficiaries against identified 34 schemes. It is important to open Aadhaar linked bank accounts for the beneficiaries under these schemes.

2. Accordingly, it is directed that District Collectors may take help from Asha Workers, Anganwadi Sevikas, Sangram operators, etc. to seed the beneficiary list under the various schemes of both Government of India and State Govt. District Collectors of Amravati, Pune(except Pune Municipal Corporation, PCMC), Nandurbar, Gadchiroli district may prepare the comprehensive list of beneficiaries under various schemes entitled and give to the Asha Workers, Anganwadi Sevikas, Sangram Operators, etc. for linking the UID numbers and Bank Accounts numbers for the beneficiaries.

3. To encourage the efforts of Asha workers, Anganwadi Sevikas, Sangram Operators, etc. for seeding of Aadhaar and bank account numbers of beneficiaries, DIT will give an incentive of Rs.10/- per UID linked with the bank account of beneficiary.
