UIDAI is requested to initiate necessary actions for removing empanelment of M/s Glodyne Technoserve Ltd from working with State and de-registering M/s Glodyne Technoserve Ltd from the UID Project in State. It is directed to ensure that M/s Glodyne Technoserve Ltd should upload all packets of the residents enrolled so far in State. M/s Glodyne Technoserve Ltd should stop all future enrolments in State with immediate effect.

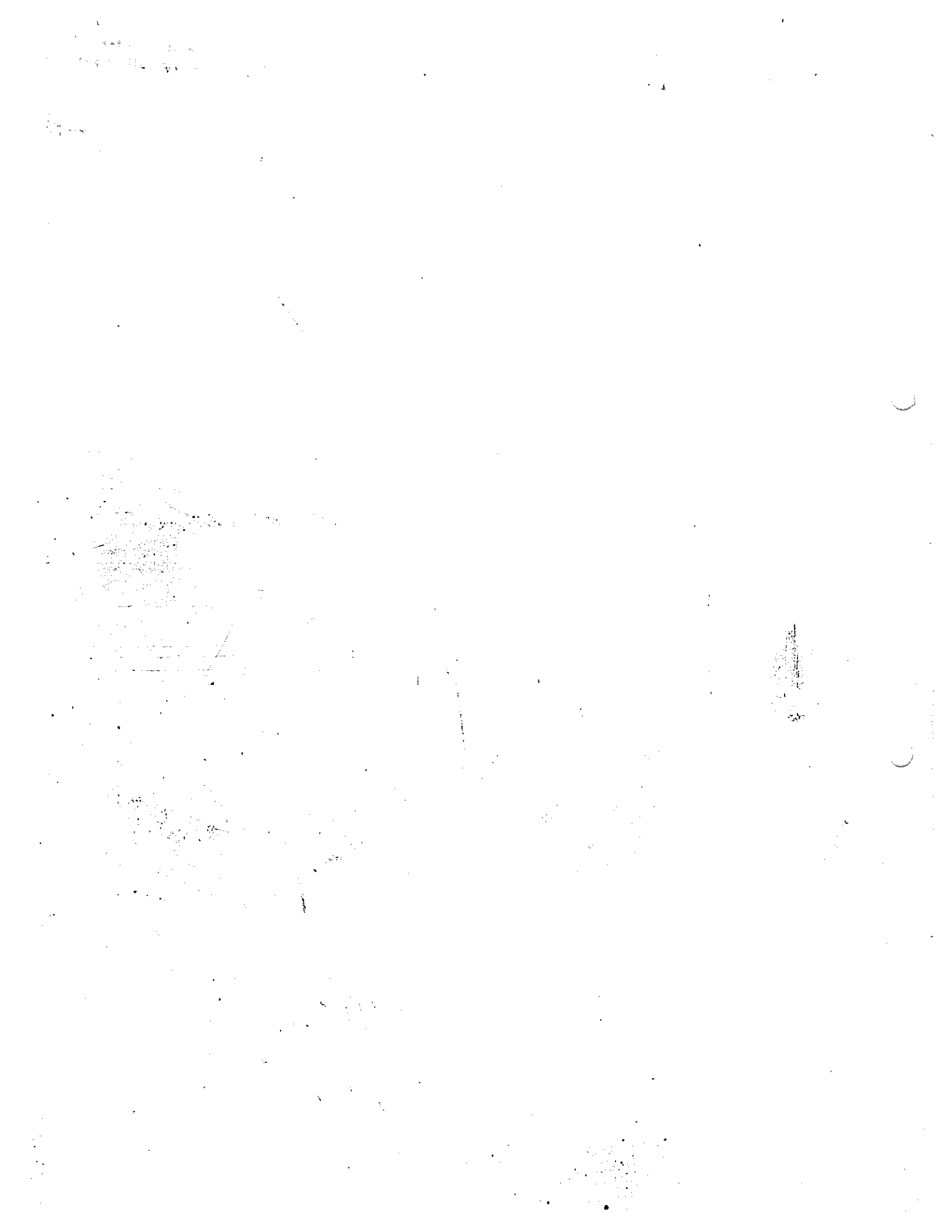

Dear Mr. Rao,

This is in reference to your appointment as an enrolment agency for Phase II of UID enrolment in Maharashtra. As per the Work Order issued to you dated 26th April 2012 (Ref. No. 1), M/s Glodyne was selected to setup enrolment centers in 54 schedules in the States. However, your organization was suspended for deficiency in services, complaints received, and non-performance for the UID enrolments in State (Ref.no. 9). The suspension was revoked with letter from DIT (Ref. No 10) and your firm was

allowed to work in revised 7 schedules with revised performance bank guarantee which was required to be submitted by 30th October 2012 to DIT.

2. Your organization has not submitted the bank guarantee for the project despite repeated reminders (Ref. 5 and 11), which is act of violation of the tender conditions. In spite of giving another chance, the responses received are unsatisfactory.

3. Presently, only 21 kits are live in Chandrapur (District and Municipal Corporation) only, as per the report of 30th November 2012. This shows that you have not honored your written commitment to State and deliberately misguided the State on UID enrolments ramp up. Your firm has ramped down in the revised 7 schedules instead of ramping up. This has again flouted the commitments given to State.

4. In light of the continuous cases of willful negligence, deficiency of services, violations to the tender conditions, misreporting to the show cause notice, suspensions and hampering the progress of UID enrolments in State, the appointment of M/s Glodyne Technoserve Ltd is immediately suspended from the UID project in Maharashtra (as you have been given sufficient time for taking corrective action, which you have not been able to take so far) and M/s Glodyne Technoserve Ltd is blacklisted from working in future in all e-Governance projects in State. No Payments for the work done in UID project be made to M/s Glodyne Technoserve Ltd.
